### Zinc ethylenebis-(dithiocarbamate) (Zineb)

(Z-005)

Your patch testing results indicate that you have a contact allergy to **Zinc ethylenebis-(dithiocarbamate) (Zineb)**. It is important that you familiarize yourself with this chemical and take steps to avoid coming in contact with it.

#### What is **Zinc ethylenebis-(dithiocarbamate) (Zineb)** and where is it found?

This chemical is used as a fungicide in cooling fluids and as a pesticide for seeds, plants, and fruit. Further research may identify additional product or industrial usages of this chemical.

#### What else is **Zinc ethylenebis-(dithiocarbamate) (Zineb)** called?

This chemical can be identified by different names, including:

*Aspor, Ebdc, zinc salt, Phyttox, 1,2-ethanediylbiscarbamodithioic acid, zinc, Asporum, Hexathane, Polyram Z, 1,2 Ethanediylbis (Carbamodithioato) Zinc, Bercema, Kypzin, Tanazon, [Ethylenebis(dithiocarbamate)] zinc, Blightox, Lonacol, Tiezene, zinc ethylenebis(dithiocarbamate), Blizene, Carbadine, Miltox, Tritoforol, zinc ethylene-1,2-bisdithiocarbamate, CHEM zineb, Novozin, Zineb 75 WP, Zinc ethylenebisthiocarbamate, Cineb, Parzate, Zinosan, Devizeb, Parzate zineb, Z-78, Zineb 80, Dipher, Perosin, Zebenide, Zidan, Dithane Z, Perozine, Zinc salt, Zebtox*

This may not be a complete list as manufacturers introduce and delete chemicals from their product lines.

### THINGS YOU CAN DO TO HELP MANAGE YOUR CONTACT ALLERGY

**Be vigilant... read the product label.** Always take the time to read the ingredient listing on product packages. This should be your first step each time you purchase a product as manufacturers sometimes change product ingredients. If you have any concerns ask your pharmacist or your doctor.

**Test the product first.** If you have purchased a new product you should test it on a small skin area to see if you get a reaction before using the product on larger skin areas.

**Advise people you obtain services from of your contact allergy.** This should include people like your pharmacist, doctor, hairdresser, florist, veterinarian, etc.

**Inform your employer if the source of your contact allergy is work related.** You should identify the specific source of the chemical and take the necessary steps to avoid further exposure. Protective wear may be adequate or you may need to make a change in your work activities. Both you and your employer benefit when the cause of your occupational dermatitis is eliminated.

**"Google" it.** The internet is an excellent source of ingredient information that can be searched by product, by company and by specific chemical.
